

## DIRECTIONS FOR USE

**FOR USE ON DOGS AND PUPPIES FROM 8 WEEKS OF AGE.  
FOR USE ON CATS AND KITTENS FROM 8 WEEKS OF AGE.  
DO NOT USE ON RABBITS.  
DO NOT APPLY NEOVEON PLUS FOR DOGS TO CATS AND VICE VERSA.**

### HOW TO APPLY:

Snap off one blister pack along the segment line. Use scissors to cut open the blister pack and peel off the foil from the cut line and take out the tube.

1. Hold the tube in an upright position facing away from you and your pet's face and eyes. Peel the ring lock off, then screw the cap off the tube.
2. Sites of Application:  
Cats - at the base of neck and between the shoulders.  
Dogs - between the shoulder blades.

3. The pet should be standing for easy application. Remove any collar prior to application and replace when product is dry. Part the hair until the skin is visible.
4. Place the tip of the tube on the skin and squeeze the tube thoroughly to ensure the entire contents are applied in a single spot on the skin. Do not apply the product superficially to the hair coat and avoid contact with the treated area until dry.
5. Make sure the tube is empty after application and discard empty tube as per the Disposal instructions.
6. Record the treatment date and repeat monthly as required.

### DISPOSAL

Dispose of empty container by wrapping with paper and putting in garbage.

### STORAGE

Store below 30°C (room temperature). See carton for batch number and expiry date.

### WATER FASTNESS

**DOGS** - Dogs may be treated with NEOVEON Plus For Dogs following bathing and shampooing once they are dry. The product will spread over the coat of the animal within 24 hours. Once spread, NEOVEON PLUS is water fast and it is recommended not to bath or shampoo dogs during the 48 hours after treatment. Thereafter, bathing, water immersion or exposure to sunlight will not reduce the efficacy of NEOVEON PLUS.

**CATS** - It's recommended not to bath or shampoo cats during the 24 hours after treatment with NEOVEON Plus For Cats. The product will spread over the coat of the cat within 24 hours. Once spread, NEOVEON Plus For Cats is water fast.

### SAFETY IN DOGS

NEOVEON Plus For Dogs has demonstrated a significant margin of safety for use in dogs and puppies and in breeding, pregnant or lactating bitches. If licking occurs shortly after application, a brief period of hyper-salivation may occur. Do not use NEOVEON Plus For Dogs if you or your pet have a known hypersensitivity to insecticides or alcohol.

### SAFETY IN CATS

NEOVEON Plus For Cats has demonstrated a significant margin of safety for use in cats and kittens over 8 weeks of age and in breeding, pregnant or lactating queens. If licking occurs shortly after application, a brief period of hypersalivation may occur due to the taste of vehicle. Do not use NEOVEON Plus For Cats if you or your pet have a known hypersensitivity to insecticides or alcohol.

### SAFETY DIRECTIONS

Will irritate the eyes and skin. Avoid contact with eyes and skin. If product enters eyes, wash it out immediately with water. Wash your hands after use.

For the treatment and prevention of flea infestation (*Ctenocephalides spp.*), and control of brown dog ticks (*Rhipicephalus sanguineus*), paralysis ticks (*Ixodes holocyclus*) and biting lice (*Trichodectes canis*) on dogs and puppies. Also aids in the control of sarcoptic mange (*Sarcoptes scabiei var. canis*) in dogs.

NEOVEON Plus For Dogs has a rapid onset of action and kills re-infestations with newly acquired adult fleas for at least one month.

NEOVEON Plus For Dogs also prevents the development of flea eggs, larvae and pupae produced by adult fleas acquired for three months after treatment.
